NOW, THEREFORE, SHERIFF, OF _____ COUNTY, you are hereby commanded to satisfy such judgment with interest and costs as provided by law out of the personal property of the Judgment Debtor, except that for any workweek, 82 percent of the disposable earnings of the debtor during that week if the gross weekly salary or wage of the debtor on the date the most recent writ of garnishment was issued was \$770 or less, 75 percent of the disposable earnings of the debtor during that week if the gross weekly salary or wage of the debtor on the date the most recent writ of garnishment was issued exceeded \$770, or 50 times the minimum hourly wage prescribed by section 206(a)(1) of the Federal Fair Labor Standards Act of 1938, 29 U.S.C. §§ 201 et seq., and in effect at the time of the earnings are payable, whichever is greater, is exempt from any levy of execution pursuant to this writ, and if sufficient personal property cannot be found, then out of the real property belonging to the debtor in the aforesaid county, and make return to this writ within less than 10 days nor more than 60 days endorsed thereon with what you have done.
