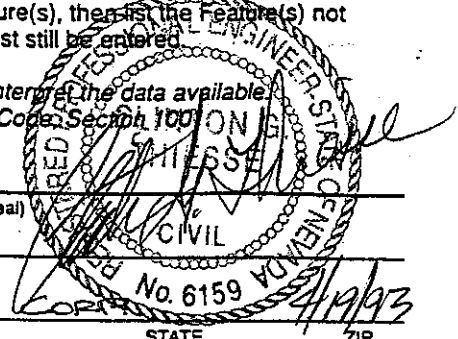

SECTION E CERTIFICATION

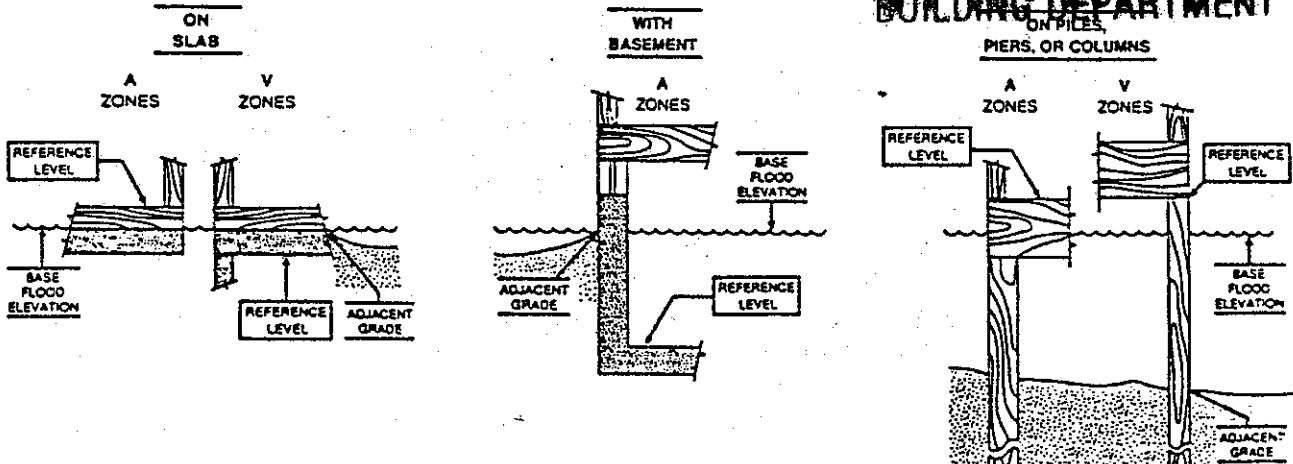
