STOREY COUNTY, NEVADA JANA SEDDON, ASSESSOR

This is the tax list of assessed valuation of the secured roll for the Fiscal Year 2013-14. Please note that your TAX BILL, not your assessed value, is capped. Your tax bill will be mailed to you in July 2013. These valuations are based upon appraisals made in accordance with the law and are for the information of the taxpayers. Pursuant to NRS 361.320 and 361.321, centrally assessed properties will not appear in the following listings, as in the past. Centrally assessed properties include, but are not limited to, power companies, telephone companies, railroads, airlines and pipelines.

DEFINITIONS

- "LAND" refers to Assessed Land Value
- "IMPROVEMENTS" refers to Assessed Value of buildings and other structures or improvements to the land
- "PERSONAL PROPERTY" refers to the Assessed Value of the personal property attached to the real property assessment roll
- "DATE" refers to the last year of appraisal or re-appraisal
- An asterisk (*) indicates a personal exemption is applied to the property

Taxes are payable to the Storey County Treasurer's Office:

- 1st Installment – August – third Monday
- 2nd Installment – October – first Monday
- 3rd Installment – January – first Monday
- 4th Installment – March – first Monday

If you disagree with the assessed valuation of your property, first contact the Storey County Assessor's Office to discuss and obtain copies of your appraisal. If you still disagree, the Assessor's Office will provide you with a form to petition the County Board of Equalization for a review of your valuation. Persons who are not satisfied with the County Board of Equalization's decision may file an appeal to the State Board of Equalization. Further appeals may be made to the District and Supreme Courts.

BOARDS OF EQUALIZATION

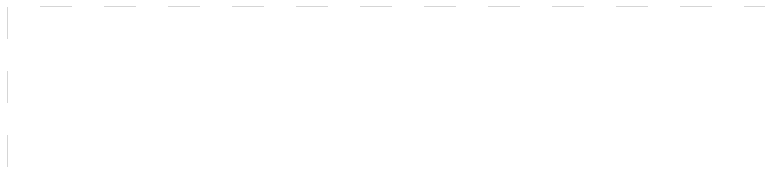
The County Board of Equalization shall hold such number of meetings as may be necessary to care for the business of equalization presented to it. The county board of equalization shall conclude the business of equalization on or before the last day of February of each year except as to matters remanded by the State Board of Equalization.

DEADLINES

COUNTY BOARD of EQUALIZATION: Appeals must be filed by January 15th, 2013
STATE BOARD of EQUALIZATION: Appeals must be filed by March 11, 2013
